# 'Pencil'

him a cataract.

About 2 years ago Dharshan took a pencil to the left eye while playing with a bunch of friends at school. And the incident didn't just stop at giving him severe pain, tears and the collective shock of everyone around him; it gave

What made matters worse is that nobody was onto his eye condition. Not until a teacher called his parents to school to tell them about his difficulty following things in class. She suggested that the problem may not necessarily be him, but his eyesight and even stated that he seemed to be having trouble reading off the blackboard. His friends joined in by saying that Dharshan repeatedly complained about not being able to see too clearly. On hearing this, his parents were understandably overcome with grief. They dreaded thinking about what this meant for their son's life.

As time rolled on, the future didn't seem to look any brighter. That was before the Sankara Eye camp came into the picture because the day he visited the camp was when



life turned a corner for the 9 year old from Keelanethinallur in Tirunelveli, Tamil Nadu. It was here that his cataract got diagnosed and he was sent to the Sankara Rural Eye Hospital where they operated on his cataract. Dharshan regained not only his eyesight but the 'life' and childhood he thought he'd lost with it.

#### 'A 12 year-old newborn'

"Anitha didn't really have what one would call a normal life till she was about 12. Her childhood featured poor grades, sitting way too close to the TV and not really being up and about like "kids her age". She was a misunderstood child. Shouted at by her parents. Made fun of by friends and relatives. What nobody knew though, was that she wasn't responsible for her failings; her visual impairment was. Anitha, who lived in Hosakote, Bangalore, was born with cataracts in both eyes. And so, at age 12, her childhood seemed blurry and her future bleak.

It all changed though when a teacher referred her to the Sankara Eye Camp. There, she was diagnosed with congenital cataracts and prescribed a procedure called ACIOL (Anterior chamber intra-ocular lens implantation)

Two life-changing things followed her operation. One, her friends and family apologized for misunderstanding her, and two, she walked out of there with something she



never knew she could have; the ability to see. After 12 years of her existence that taken-for-granted normality we all call life had finally come her way. And it wasn't just her vision that was corrected post treatment, but her entire views on what her life could have in store.

## Validation of Mission for Vision's Patient Care Review (PCR) process



Owing to an increase in scale, MFV put in place this Patient Care Review Process to gauge patient satisfaction and arrive at Impact Assessment across partner eye care institutions in India. The only organisation to be doing this on a pan India basis, this assessment would be done by referring to various socio-economic indicators.

5 years into this initiative, MFV decided on having an independent evaluation of the PCR process so that the entire system could be institutionalized and extended to not only partners but other eye-care institutions as well.

Prashasa Health Consultants Pvt. Ltd. was tasked with this process validation. And they introduced a methodology where through stakeholder engagement and face-to-face meetings, primary data was collected, analyzed and the system, in its entirety, reviewed.

The study's findings stated that MFV was adding immense value to the field of eye care and eye-related healthcare delivery. It also confirmed MFV's effort, commitment and performance as laudatory.

Prashasa Health Consultants made the following recommendations to improve upon an already successful system:

- The process could be made more scientifically robust with modification of methodology.
- The development of vision specific function impact variables. The need for expedited and more easily accessible data management systems.
- The provision of technical training and support to human resources.
- It was largely felt though that PCR had the makings of a system that could be significantly scaled up and address a vital aspect of eye care delivery. To date, the implementation of the above recommendations have been put in place.



# Patient Care Review (PCR) for April through June 2014

In this period, 3477 patients were surveyed of which 43% were males and 57% females and overall 91% of them had what is classified as good visual acuity.
